AVMHS Annual Meeting Program

The evening of Thursday, July 6, welcomed a highly informative and enjoyable presentation by Dr. Susan D. Jones. She is currently Distinguished McKnight University Professor in the Program in the History of Science and Technology, Department of Ecology, Evolution and Behavior at the University of Minnesota in St. Paul, Minnesota. She is also past president of AVMHS (2001-2002) and former board member.

Introduced by Program Chair Dr. John de Jong, Dr. Jones' talk on "Global Aspects of the History of Veterinary Medicine" was well received by more than 40 members and guests in attendance.

--- Highlights on Global Veterinary History

Using a series of colorful slides, Dr. Jones described several patterns, outcomes, and results to emphasize a global approach to the history of veterinary medicine and point out how changes have happened worldwide.

Related to the connection, aspiration, and synthesis of natural histories, she mentioned trade, war, and the activities of common people and cited various outbreaks of rinderpest as an example. Another pattern concerned the different types of systems for animal healing prevalent through the ages, such as in India and China. Also, as addressed by RH Dunlop (see reference below)

was the disparity between Claude Bourgelat and Philippe-Étienne Lafosse as the French model of veterinary education spread over the past 200 years. Because of the lack of veterinary school graduates, animal healers typically filled the gap by providing needed medical care services in communities.

She also spoke about a further trend concerning "who was first," particularly for women in veterinary medicine, which has resulted in a modern change in gender balance. Furthermore, milestones in microbiological studies and therapy have played a significant role. Increased understanding of contagion grew out of the germ theory in the 19th century followed by expanded knowledge of viral diseases. More research is needed on veterinary medicine's contributions to history.

Dr. Jones said developments in biomedical technology (microscopes, antibiotics, imaging) undoubtedly have had a tremendous impact. Dr. Jones predicted further advancements would continue in the future as old and new intersect and combine.

Finally, from Virchow's pronouncement of a One Health concept, today's environment increasingly reflects the need for attention to both human and animal health. She feels veterinary medicine will continue to advance in a changing world as history provides the lessons.

Several questions followed Dr. Jones's most enlightening and instructive presentation.
